I. INTRODUCTION

beta-Hydroxybutyrate Dehydrogenase (EC 1.1.1.30), ask known as BHBDH, is found in the mitochondria and catalyzes the oxidation of 3-hydroxybutyyrate to acetoacetate and it uses NAD as a coenzyme. This enzyme catalyzes the reaction of (R)-3-hydroxybutanoate and NAD+ into acetoacetate into NADH and a free H+. beta-Hydroxybutyrate Dehydrogenase Microplate Assay Kit provides a simple and direct procedure for measuring beta-Hydroxybutyrate Dehydrogenase activity in a variety of samples. In this colorimetric beta-Hydroxybutyrate Dehydrogenase quantification assay, beta-Hydroxybutyrate Dehydrogenase reduces NAD to NADH, which then interacts with a specific probe to produce a color. The rate of increase in the absorbency at 450 nm, is a measure of beta-Hydroxybutyrate Dehydrogenase activity.



II. KIT COMPONENTS

Note:

Dye Reagent A: add 9 ml distilled water to dissolve before use, mix, store at 4°C.

Substrate: add 9 ml Assay Buffer to dissolve before use, store at -20 °C.

Standard: add 1 ml distilled water to dissolve before use; then add 0.15 ml into 0.85 ml distilled water, the concentration will be 300 μ mol/L, store at -20 °C.

Positive Control: add 1 ml Assay Buffer to dissolve before use, then add 0.1 ml into 0.9 ml Assay Buffer, store at -80 °C.



III. MATERIALS REQUIRED BUT NOT PROVIDED

- 1. Microplate reader to read absorbance at 450 nm
- 2. Distilled water
- 3. Pipettor, multi-channel pipettor
- 4. Pipette tips
- 5. Mortar
- 6. Ice
- 7. Centrifuge
- 8. Timer

IV. SAMPLE PREPARATION

1. For cell and bacteria samples

Collect cell or bacteria into centrifuge tube, discard the supernatant after centrifugation, add 1 ml Assay buffer for 5×10^6 cell or bacteria, sonicate (with power 20%, sonicate 3s, interval 10s, repeat 30 times); centrifuged at 8000g 4 °C for 10 minutes, take the supernatant into a new centrifuge tube and keep it on ice for detection.

2. For tissue samples

Weigh out 0.1 g tissue, homogenize with 1 ml Assay buffer on ice, centrifuged at 8000g 4 °C for 10 minutes, take the supernatant into a new centrifuge tube and keep it on ice for detection.

3. For serum or plasma samples

Detect directly.



V. ASSAY PROCEDURE

Add following reagents into the microplate:

Mix, incubate at room temperature for 5 minutes, record absorbance measured at							
450 nm.							

Note:

- 1) Perform 2-fold serial dilutions of the top standards to make the standard curve.
- 2) For unknown samples, we recommend doing a pilot experiment & testing several doses to ensure the readings are within the standard curve range. If the enzyme activity is lower, please add more sample into the reaction system; or increase the reaction time; if the enzyme activity is higher, please dilute the sample, or decrease the reaction time.
- 3) Reagents must be added step by step, can not be mixed and added together.



VI. CALCULATION

Unit Definition: One unit of β -HBDH activity is defined as the enzyme produce 1 μ mol NADH per minute.

1. According to the volume of serum or plasma

2. According to the protein concentration of sample

-HBDH (U/mg) = (C_{Standard} × V_{Standard}) × (OD_{Sample} - OD_{Control}) / (OD_{Standard} - OD_{Blank}) / (V_{Sample} × C_{Protein}) / T
$$= 0.6 \times (ODSample - ODControl) / (ODStandard - ODBlank) / CProtein$$

3. According to the weight of sample

$$β$$
-HBDH (U/g) = (C_{Standard} × V_{Standard}) × (OD_{Sample} - OD_{Control}) / (OD_{Standard} - OD_{Blank}) / (W × V_{Sample} / V_{Assay}) / T
$$= 0.6 × (ODSample - ODControl) / (ODStandard - ODBlank) / W$$

4. According to the quantity of cell or bacteria

-HBDH (U/10⁴) = (C_{Standard} × V_{Standard}) × (OD_{Sample} - OD_{Control}) / (OD_{Standard} - OD_{Blank}) / (N × V_{Sample} / V_{Assay}) / T = 0.6 × (OD_{Sample} - OD_{Control}) / (OD_{Standard} - OD_{Blank}) / N

 $C_{Standard}$: the concentration of standard, 300 µmol/L = 0.3 µmol/ml;

C_{Protein}: the protein concentration, mg/ml;

W: the weight of sample, g;

V_{Sample}: the volume of sample, 0.01 ml;

V_{Standard}: the volume of standard, 0.1 ml;

V_{Assav}: the volume of Assay buffer, 1 ml;


T: the reaction time, 5 minutes;

N: the quantity of cell or bacteria, $N \times 10^4$.




VII. TYPICAL DATA
